The Campaign is only open to legal residents of Texas, and is void where prohibited by law. The Campaign is subject to all applicable federal, state, and local laws and regulations. 4. **How to Enter:** The Coloring Contest must be entered by completing the coloring sheet designated for your age group and submitting it to the Marketing Department at Cooperative Teachers Credit Union by the submission deadline. The entry must fulfill all Campaign requirements, as specified, to be eligible to win a prize. Entries that are incomplete or do not adhere to the rules or specifications may be disqualified at the sole discretion of Cooperative Teachers Credit Union. You may enter only once.
